Dário Moura Vicente graduated in Law at the Portuguese Catholic University (in 1985), where he also completed a postgraduate course in European Studies (in 1987) and obtained his LL.M. degree (in 1990).

He received his Doctorate in Law (in 2000) and the title of Aggregate (in 2009) from the University of Lisbon.

He is a Full Professor (*Catedrático*) at the Faculty of Law of the University of Lisbon, where he has taught, since 1989, Civil Law (General Theory and Law of Obligations), Comparative Law, Private International Law, International Commercial Law, and Intellectual Property Law.

He has also lectured at The Hague Academy of International Law (in 2008), at the Paris V University (in 2010), at the Urbino University (in 2011), and the Complutense University of Madrid (in 2012).
