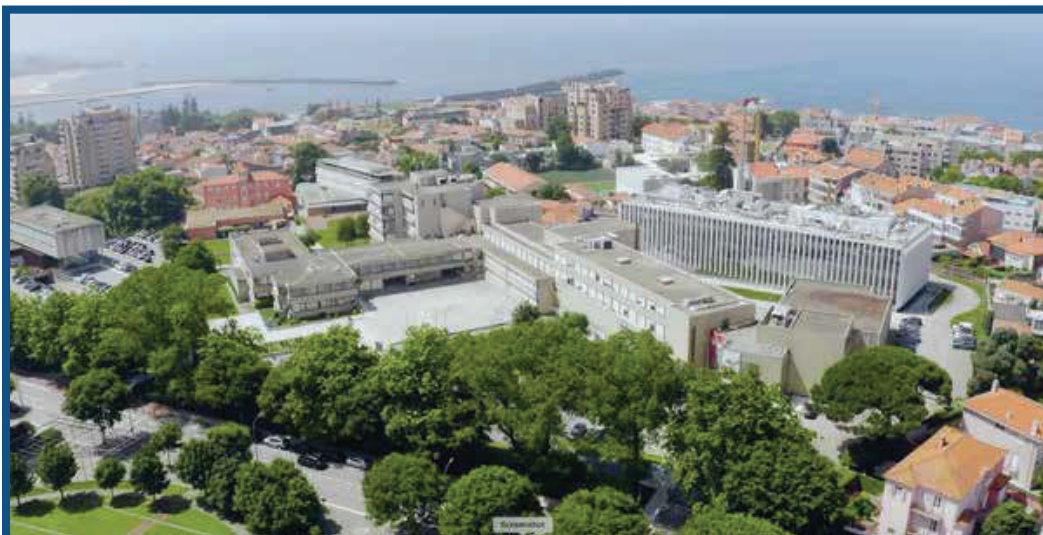

The Summer Study Abroad Program offers students reference tools, and practices for conflict resolution through an innovative teaching experience focused on developing the soft and hard skills needed today.

## Main Program & Workshops

This program is suitable for participants interested in developing skills in negotiation and mediation and who have the ambition to integrate an international network of professionals who lead the development of alternative dispute resolution and online dispute resolution on a global scale.

It also integrates different workshops with specific themes – negotiation, family, insolvency, commercial mediation – that will allow participants to have an experience of interactive learning, building relationships and problem-solving skills.

**This Summer Program offers 3 ECTS** (European Credit Transfer and accumulation system)





### **MEDIATION**

The student will have the opportunity to learn about the best practices in conflict mediation in the international context, from the different stages of the conflict resolution process to the role of the mediator and the lawyer in the mediation process.

### **NEGOTIATION WORKSHOP**

With the use of international case studies, participants will have the opportunity to apply and practice different negotiation techniques applied to mediation and conflict resolution.



### **NEGOTIATION**

In these modules, the student is challenged to understand the main phases and techniques of the negotiation process, to draw up an agreement between the parties.

### **FAMILY MEDIATION WORKSHOP**

This workshop will provide participants with the learning and application of specific skills and abilities for conflict resolution in a family context.



### **ONLINE DISPUTE RESOLUTION**

The student will learn in-depth the critical techniques of online communication, from formulating messages to being fully present in meetings and online facilitations.

### **MEDIATION CLINICS**

Through hands-on practice, students gain an introduction to the benefits and limitations of mediation and other dispute-resolution techniques to counsel clients responsibly about their options to resolve conflicts.

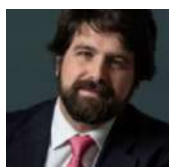

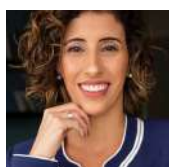

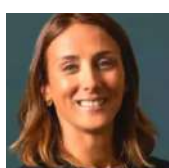
