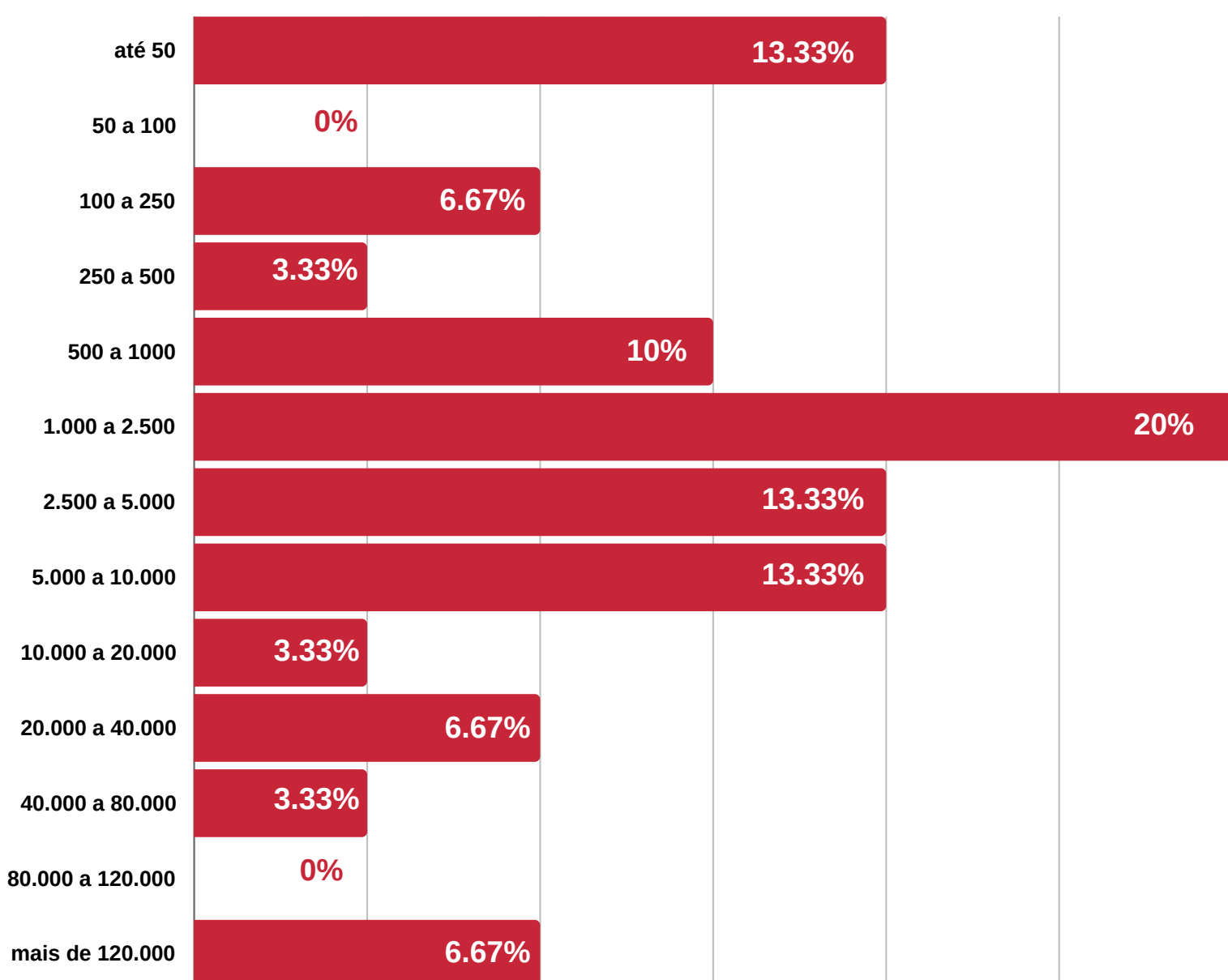

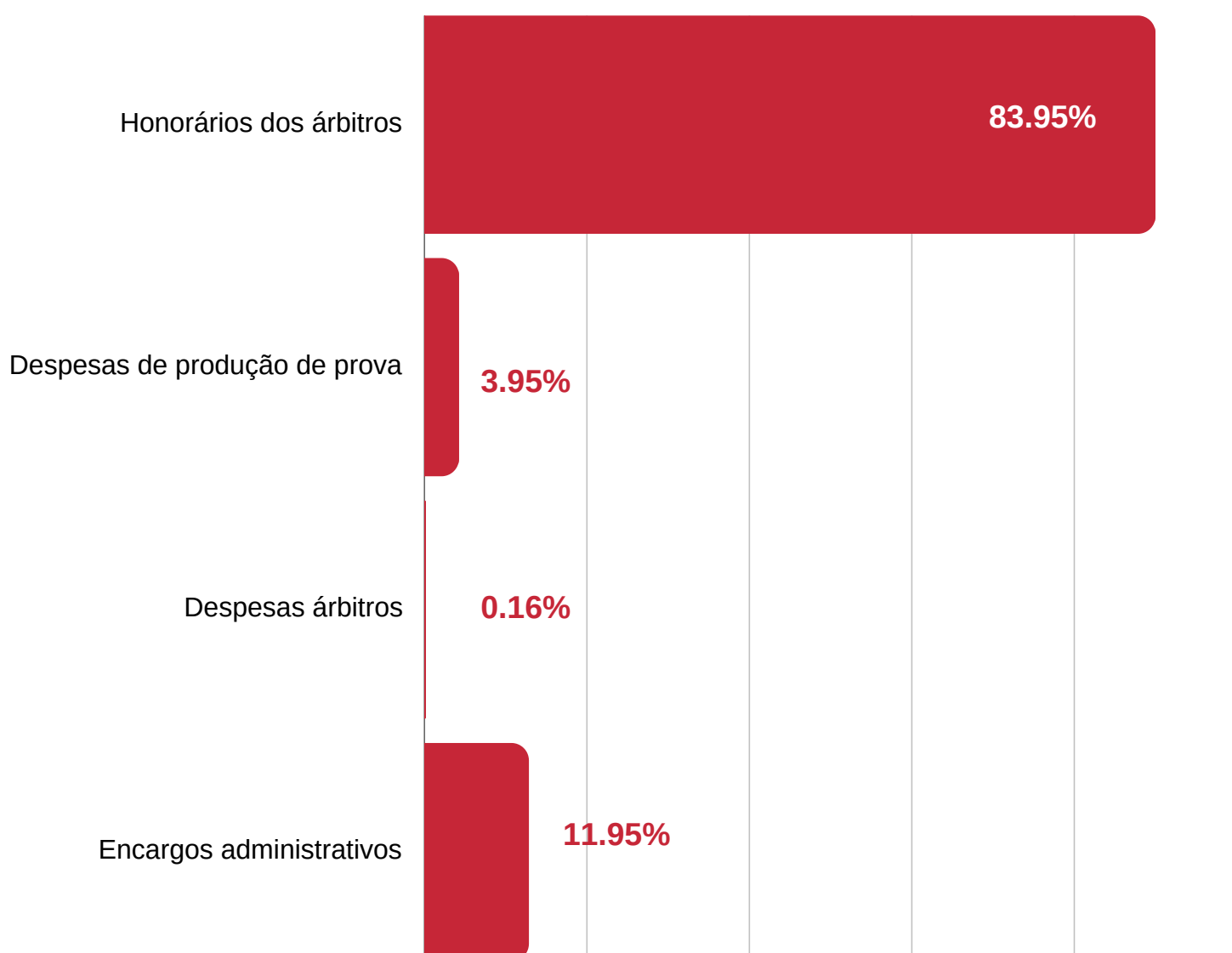

## DISTRIBUIÇÃO DOS CUSTOS DE ARBITRAGEM POR ESCALÕES DE VALOR

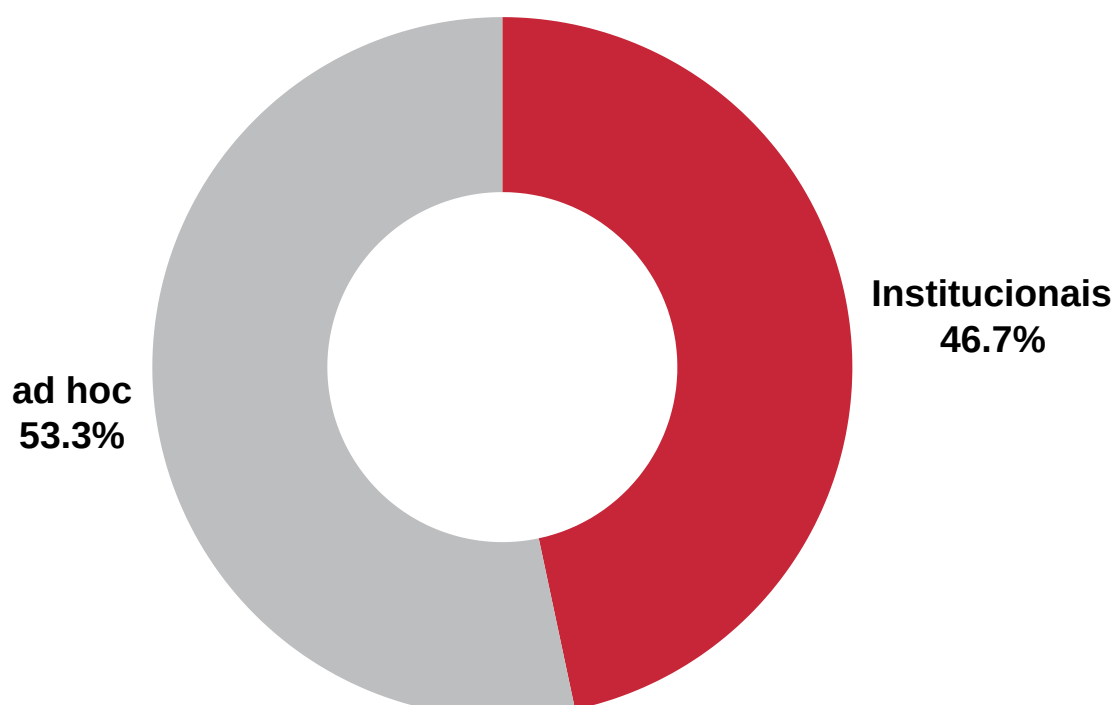

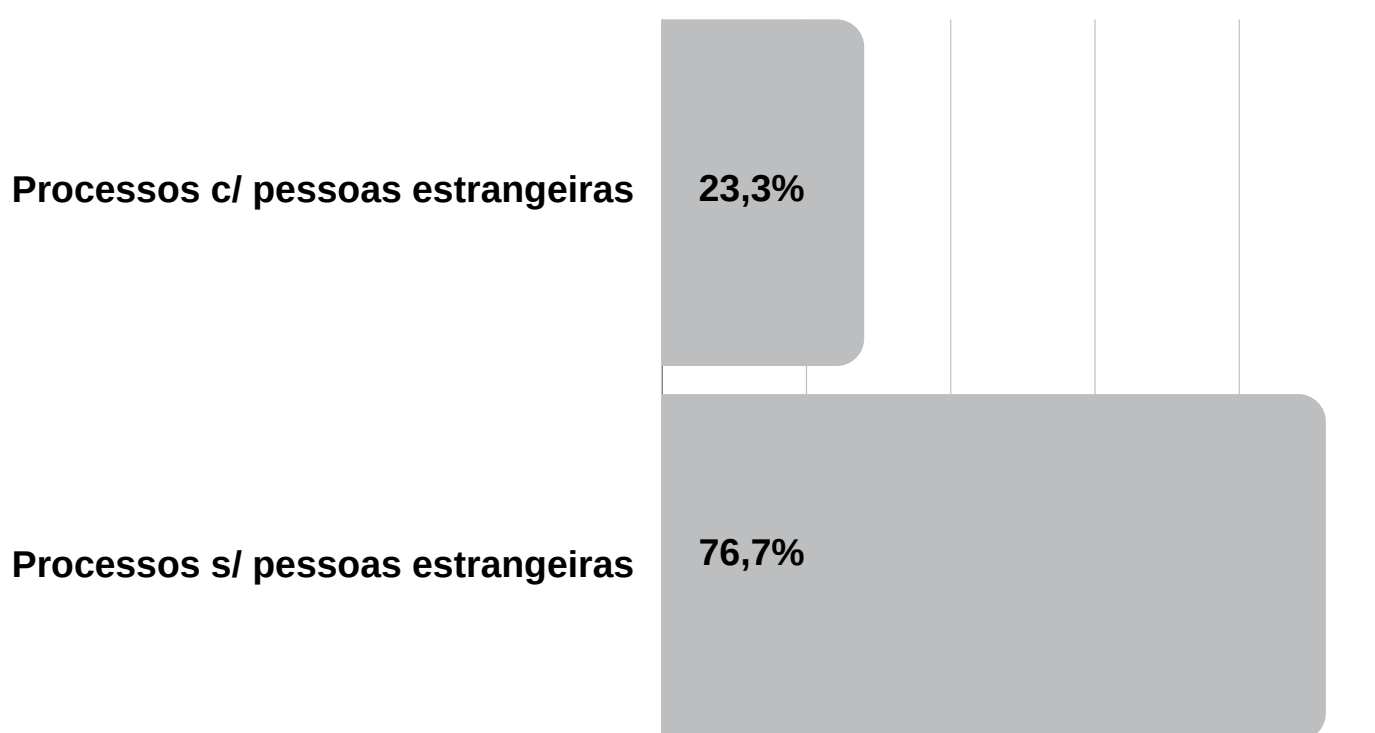




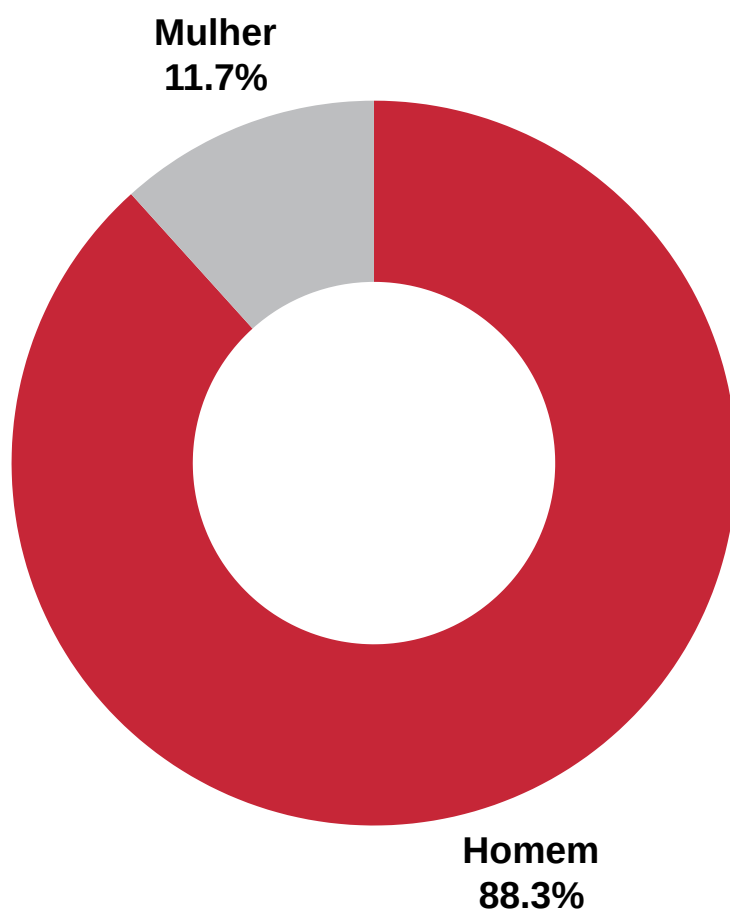

## NACIONALIDADE DAS PARTES

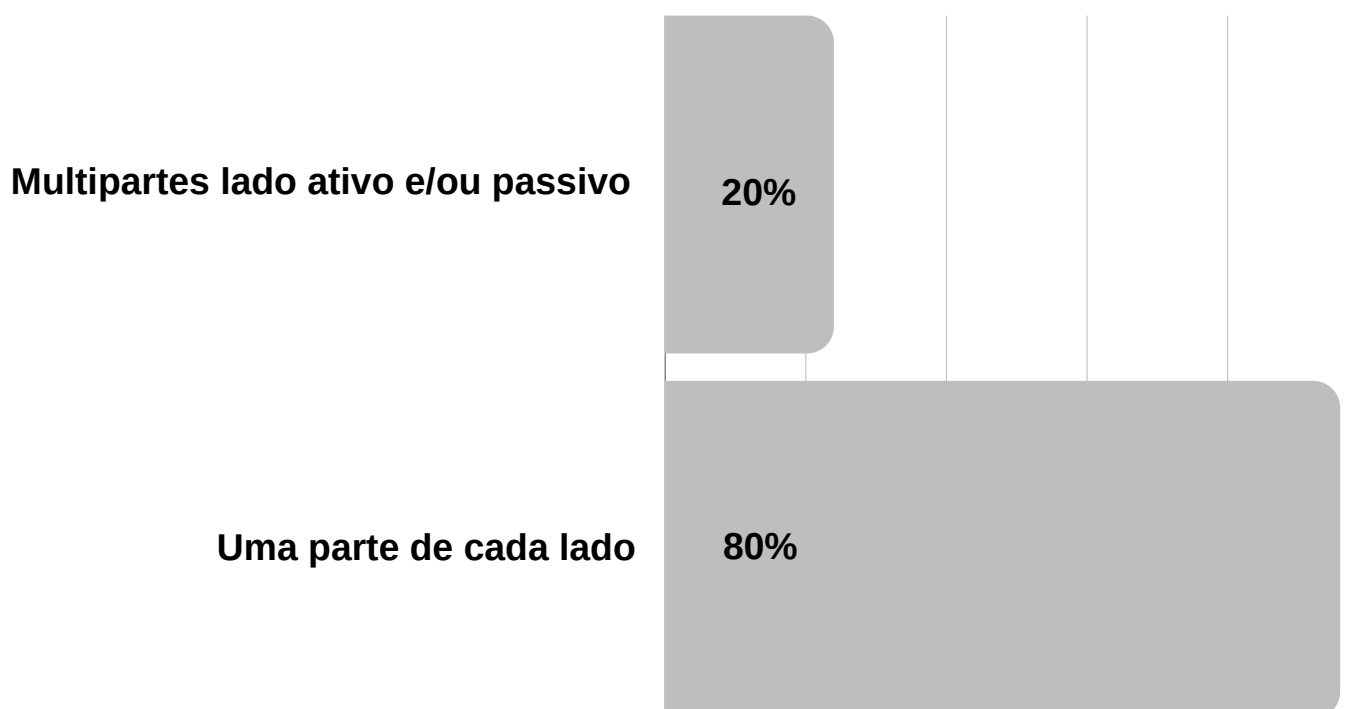


## GÉNERO DE ÁRBITROS

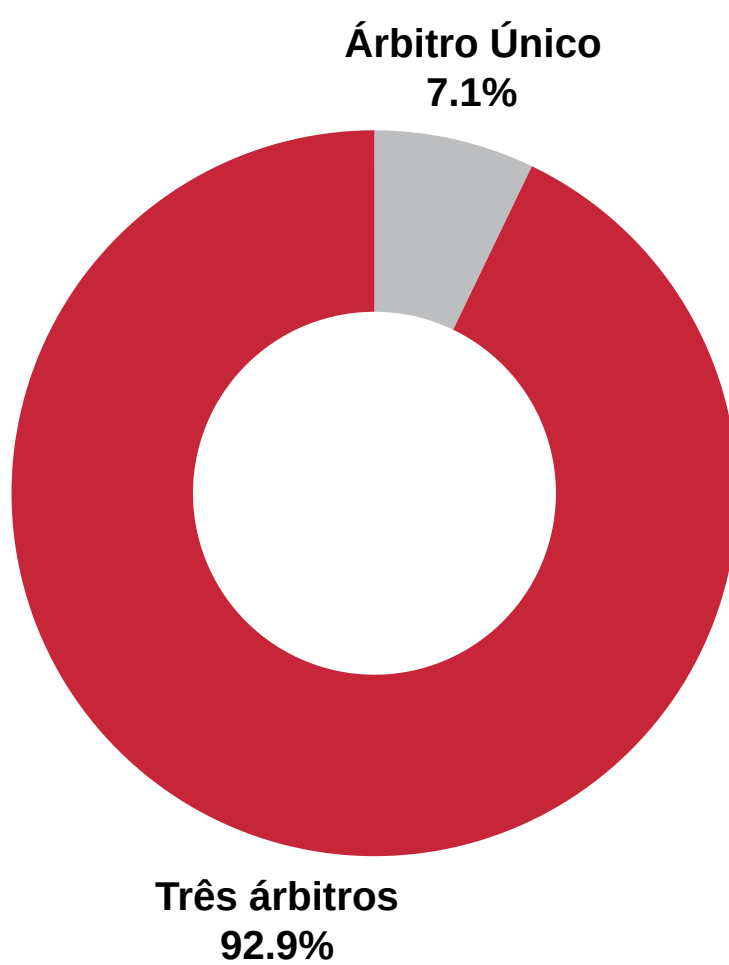




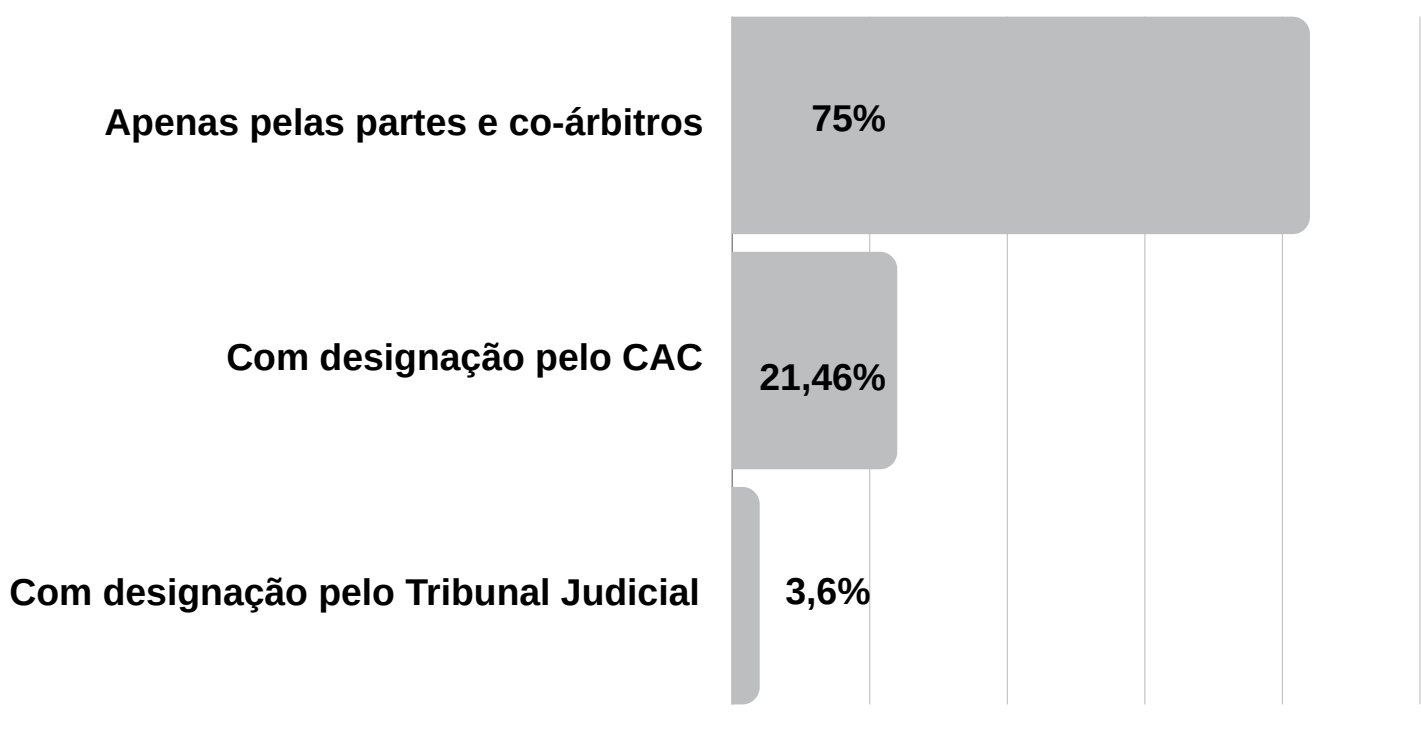

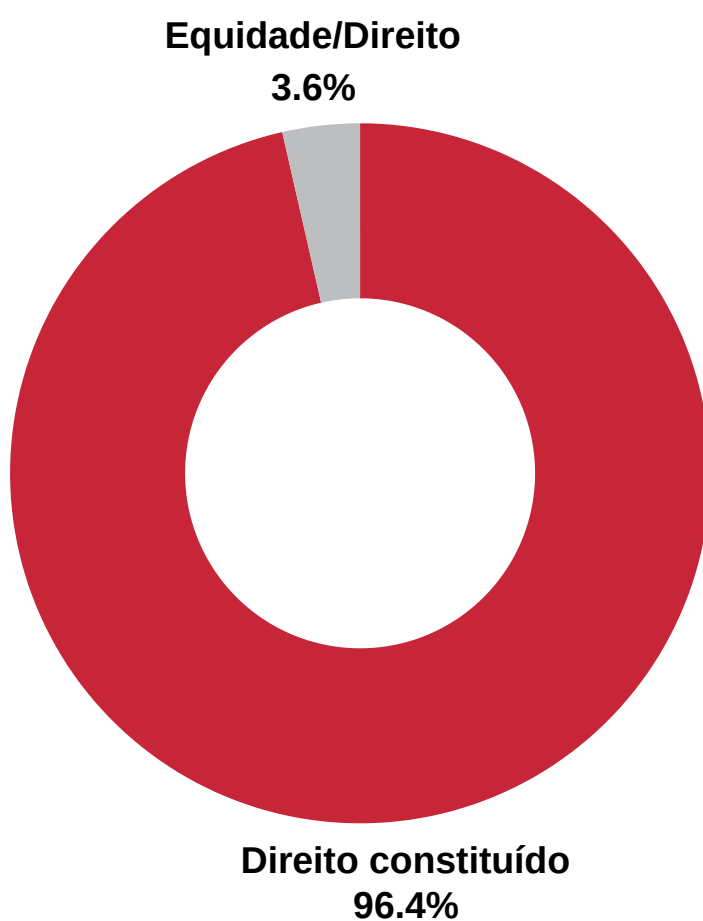

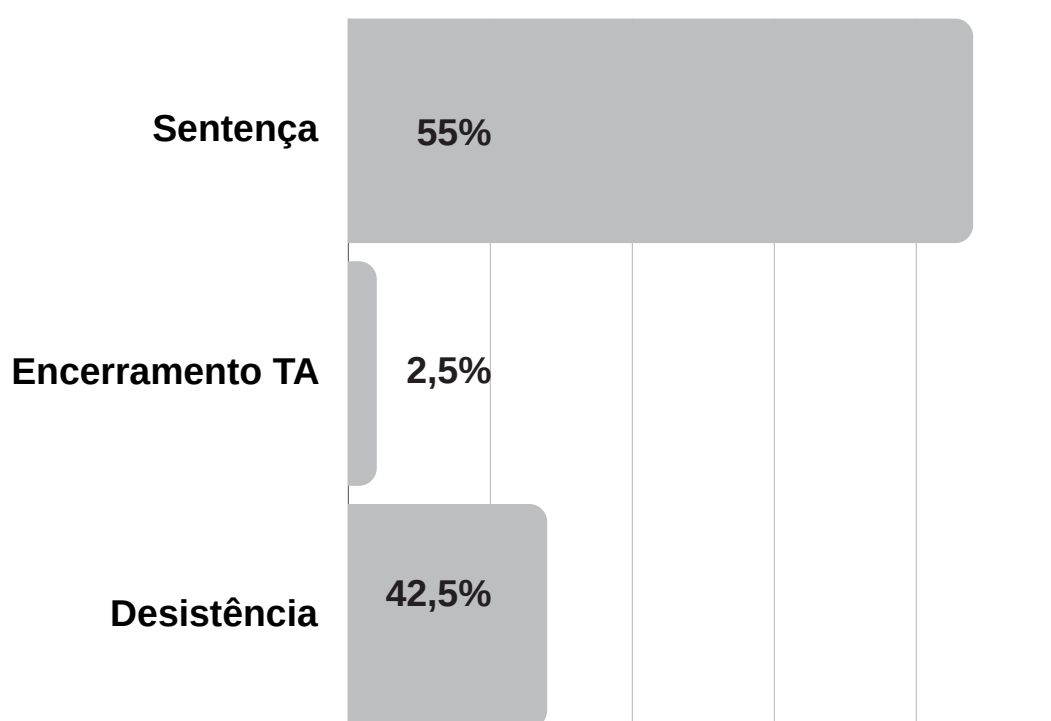

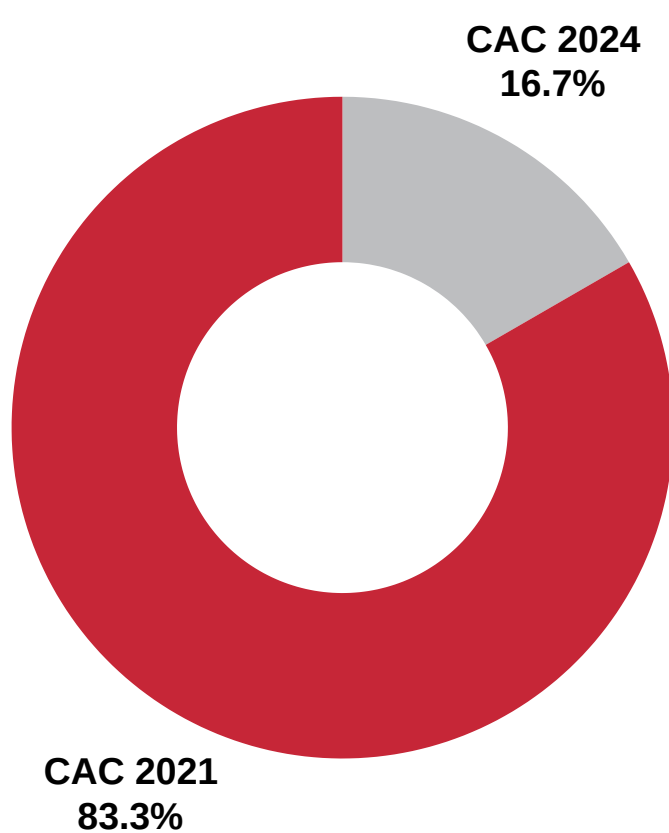




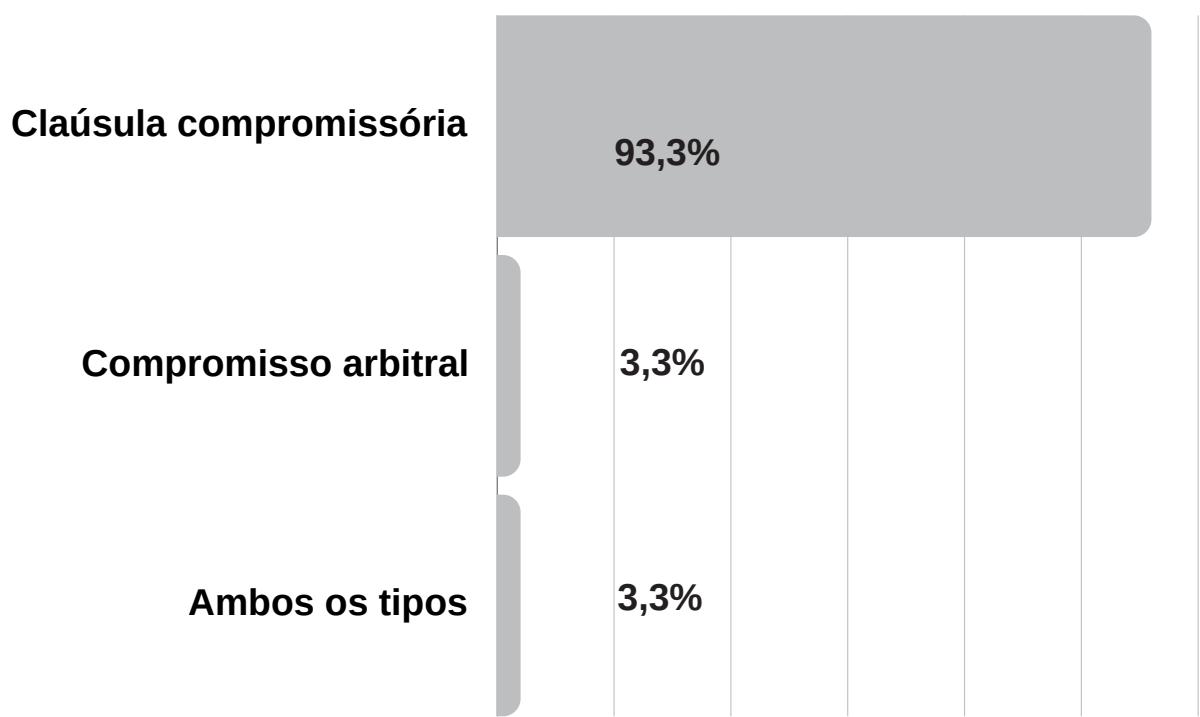
## MODO DE CONCLUSÃO DO PROCESSO

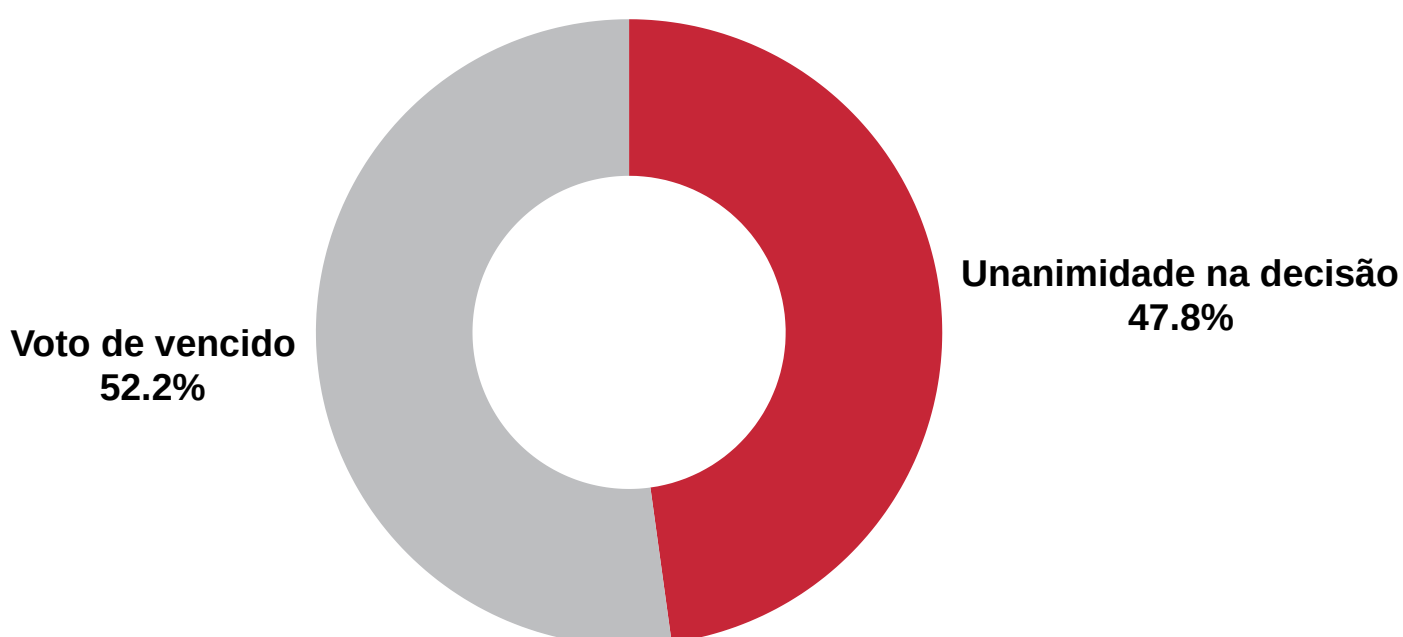
